Motion to authorize the application to the United States Environmental Protection Agency under their National Clean Diesel Funding Assistance Program for a grant of approximately \$800,000 toward the cost of upgrading diesel engines in the fleet of Anderson Coach & Travel, Inc., Greenville, PA. The County would serve as Grantee and Fiscal Agent for the grant at no cost to the county. Anderson as sub-grantee would invest approximately \$3.2 million as required matching funds. Grant period would be approximately two years after date of award. We appreciate the assistance of Penn-Northwest Development Corp. in providing the regional economic statistics required for the grant application.
