#### APPROVAL OF MINUTES FROM THE 8/14/13 MEETING AS PRESENTED

#### TREASURER'S REPORT

A motion was made by Jerry Johnson and seconded by John Lechner to approve the treasurer's report as presented. Motion carried. ### **OLD BUSINESS**

- 1. Acceptance of a Bank Proposal for \$1,383,000 Local Share. Lisa Chiesa (Clark Hill Thorp Reed), pursuant to our instruction at the last meeting contacted the following (3) local banks: Mercer County State Bank; First National Bank (not interested); Greenville Savings Bank (no response). Roger passed out an email from Mercer County State Bank. Originally on 10/4/13, their quote included a quarter point origination fee but after Roger talked with Lisa and MCSB they removed it. The email stated that the fee was eliminated; the term was 3.5 years at 2.25% interest; no loan fee; collateral is the guaranty from both townships; repayment source would be tap-in fees; bond counsel will hold the closing; no penalty for paying off early; they require the commitment of Rural Development Funding and establishment of operating deposits with the bank. A Resolution of the Board was made by John Lechner and seconded by Pat Suhrie to accept the proposal from Mercer County State Bank for the financing of our share of the funds needed for this project. Resolution carried.
- 2. Authority Personnel Dan provided a list from a similar project he worked on as a sample/guide so we could get an idea of what the operating costs would be for administration and plant. Also included are job descriptions.
- 3. Initial O & M Budget for Sewage Facilities Project.
- 4. First Year of Authority Operation's Budget.

#### **NEW BUSINESS**

- 1. Legal Counsel Services Agreement Amendment \$60,000 plus \$3000 out-of-pocket expenses. A motion was made by John Lechner and seconded by Pat Suhrie to accept the Legal Counsel Services Agreement presented for Authority Solicitor (Roger Shaffer). Motion carried.
- 2. Fidelity or Employee Dishonesty Bond Required by RUS. They require \$161,000 bond and will cost about \$1500/year and will cover all Board members for any allegation of misconduct. A motion was made by Pat Suhrie and seconded by Bob Gregory to permit Dan to obtain bond quotes for the next meeting. Motion carried.
