Motion to accept the low bid and award a contract for roof replacement and waterproofing project at the Mercer County Courthouse. Low bidder is Triangle Roofing Inc. Pittsburgh, Pa. in the amount of \$832,860.00. Additional add on costs are \$32,315.00 for zero odor VOC formulation and \$85,000.00 to increase to a forty year no dollar limit edge to edge warranty product. Total cost will be \$950,175.00. There will also be a maximum allowable cost for up to 8 new roof drains at \$800.00 per drain for a total of \$6,400.00. An allowance of up to 1500 square feet of vapor barrier repair at \$10.00 per square foot for a maximum allowance of \$15,000.00. Both of these allowances are undeterminable if they need replacement or repairs until roof tear off and visual inspection confirms the need for their replacement. These two items will require County inspection and written authorization to proceed. If both of these additional two allowances reach maximum pay out the total would be \$971,575.00. Subject to execution of all contracts and related agreements.
