DISCUSSION: OPIOID CRISIS

Commissioner Boyd stated that this is not a casual lawsuit. The manufacturers have made false claims and it has led to over prescribing and abuse of opioids. This often evolves to heroin use and has become a huge social cost to the residents of Mercer County.

Commissioner McGonigle concurred and said it is one of the ways to help stop the epidemic in the community.

Commissioner McConnell said he has been upset by what he has learned from his interaction with PCCD and that this is one of the tools that is timely and may be effective in combatting the opioid crisis.

Commissioner McConnell said that these funds are spent locally and that the County appreciates helping communities to improve parks and public spaces. Fiscal handles inquiries. Pending requests are in process from Fredonia and Perry Township. Mercer County has never declined a request, to date, and encourages great partnerships such as the project done in conjunction with the "River Watchers."
