Application for Use of Courthouse Grounds for "The Return, National and Global Day of Prayer and Repentance" on 09/26/2020 was approved.

Fiscal reported the Budget process for 2021 is underway. Difficulties include increases in costs and the elimination (non-renewal) of the County Per Capita Tax. Historically the tax generated approximately \$250,000 per annum in revenue. Commissioners commented that the collection efforts were inefficient, and they understand the need to make up the shortfall.

Commissioners reported on the 2020 Census. 68% of Mercer County households have reported as compared to 67% for Pennsylvania and 63% nationally. It is very important for everyone to report. The data helps to provide federal funds for roads, bridges, schools, libraries and parks as well as safety and emergency services. The data is used by businesses to determine if they will locate in Mercer County; thereby contributing to the economic strength of the county. All residents including renters should complete the census. It may be completed online at 2020census.gov or by phone at 844-330-2020 or in person with a local Census Taker. All information is confidential and secure. It is never shared with any agency, law enforcement or government authority. Census data collection ends 09/30/2020.

Commissioners reported that they attended the Farm Bureau annual legislative meeting. They reminded residents that Farms are considered businesses, and they have also been impacted by the coronavirus. Agriculture is experiencing extreme stress due to the limited number of food processors. Both the farmer and the customer are realizing higher prices and no increase in profits.
