General Discussion Items: See Below.

Craig Conforti, PennState Extension, and Jay Russell, Mercer County Conservation District discussed the Spotted Lanternfly 2022 Quarantine in Mercer County. The Department of Agriculture announced a quarantine as of 04/01/2022 for eleven (11) counties in Pennsylvania including Mercer. When evidence of reproducing population is identified in a community, the entire county is placed under quarantine.

When a county is under quarantine, permits are required for businesses and other entities that travel inside and outside of the county. There is no cost for the permit. A "train the trainer" class must be completed, and a log of travel must be maintained for two (2) years.

Mercer County Conservation District focuses on protection of natural resources from invasive species. They travel to other parts of Pennsylvania and therefore they obtained a permit in 2018. The Conservation District regularly inspects its vehicles per the travel log requirements.

PennState Extension is a cooperative agency working to educate the community and to provide resources. The spotted lanternfly is a dangerous "hitchhiker" insect that was identified in Bucks County in 2014. It is very damaging to maple trees, fruit trees and crops such as grapes. Mercer County and PennState Extension are posting educational information, including a video, management guide, business toolkit and a residential checklist on its websites.

Community members are encouraged to contact either PennState Extension at 724-662-3141 for more information, or Pennsylvania Department of Agriculture at 888-4BADFLY (888-422-3359) to report sightings. At this time there is no definitive treatment and research to eradicate the infestation that is ongoing.
