General Discussion Items: See Below. The next scheduled Commissioners Meeting is 11/17/2022.

Voter Registration/Election Director, Thad Hall, reported 78% of mail-in ballots have been returned. In response to concerns about slow mail times, USPS is implementing new procedures to expedite sorting and delivery of election mail, especially at the Pittsburgh sorting facility that serves Mercer.

Commissioners asked about mail time from Florida. Based on postal studies there is a 7-to-9-day window for mail delivery to Florida. Electors are encouraged to return their ballots in person to the Election Office at 130 N. Pitt Street. The deadline to return ballots is 8:00 PM on election day. Historically about 100 ballots have been returned on election day. Electors may also opt to surrender a mail-in ballot and envelope at their precinct and vote in person on election day.

Hall discussed issues concerning the Department of State SURE system. It was not designed to support mail-in ballots and duplicate labels can be issued in error occasionally. It is due to be replaced next year by a new software program that is more robust and aligns with the election code and current guidelines. The Voter Registration/Election Office does keep track of problems as they are identified.

Treasurer White confirmed that hunters also have complained about mail delivery times in Mercer.

Commissioners discussed parking by the Republican Headquarters across the street from the Courthouse. Their parking area is limited to 12' behind the building. With a busy election season, it can be difficult for employees to access County parking spaces.

Public Comment: Fiscal Administrator Logan recognized Jerry Zona and Megan Gahring from Lawrence-Mercer Recycling/Solid Waste Department. The DEP grant based on the collection of tonnage is a substantial benefit to Mercer County. Zona reported that the tonnage has steadily increased despite the elimination of glass from recycling. The grant amount has declined from approximately \$38,000 in 2019 due to changes in the calculation by DEP.

Zona also discussed proper recycling of batteries including alkaline, re-chargeable and lithium style. They should not be thrown away. Certain home improvement stores, such as Lowe's or Home Depot, will accept them or you can look for advertised recycling events in the community.
