# General Discussion Items: See Below.

The Whole Home Repairs Program is anticipated to begin in July. The grant application is being submitted to the State by the grantee this week. Information will be available to the public later this year concerning "how to apply."

Commissioners discussed the Route 62 tunnel project. Representative Kelly submitted a request for funding from the Ways and Means Committee in April 2022 for replacement of the railroad tunnel on Route 62 that is owned by Canadian National Railroad. The bill was signed December 2022 and \$3MM will be granted to PennDOT for this project. Estimated replacement cost is \$10MM to \$15MM. The project has been in discussion stages since October 2017 with many partners collaborating on a solution, including a study completed by PennDot in 2019 and 2020. Commissioners recognized and thanked Congressman Kelly for the approval of the "seed" money to initiate the project.

Commissioners shared that with the exitus of PNC Bank, Juvenile Probation has requested to park in two spaces adjacent to their building that had been previously occupied by PNC staff.
