The flow meter is not working and we will be given a temporary one until ours is repaired.

Pictures were provided of where the concrete caved in and the gravel has settled. Dan has told Jim he has no idea where the gravel went. The area where the plant is sitting was never stripped. UV tanks are working properly. There was discussion on what happened to cause this and how to fix it. The board would like to see Gannett Fleming's review of inspections for the concrete pad/gravel installation for liability.
