Affordable Solutions For Corporate Expansion

As Mercer County's Certified Economic Development Organization, Penn-Northwest contracted with Mercer County to administer the CHIRP (COVID Hospitality Industry Recovery Program) Grant on behalf of the County. The total grant amount was \$1,239,376. PNDC received applications via electronic submission and in-person delivery. Penn-Northwest received \$34,376 in fees for grand administration. A total of \$1,205,000 was awarded to the local community. Grants were awarded in amounts ranging from \$5,000 to \$50,000 in \$5,000 increments. Grants were awarded in the following distribution:
