ENGINEER'S REPORT

Dan Goncz stated that the various facilities are listed YTD. Plantation Park is at 60 edu's through May/2022.

Thompson Rd. Pumpstation: Bids were opened on 6/8/2022. (7) bids were received for the general and (2) for the electrical. These are attached to the Engineer's written report. The lowest bids were: Contract #1.) Penn West Specialized Contracting/Grove City - \$267,851.00. Contract #2.) Penn Ohio Electrical/Masury, OH - \$18,800.00.

The last page of the report includes a spreadsheet that shows total project costs of \$331,000.00. This is 10% higher than we thought we would be. The authority will have spent \$20,500.00 already towards this project. The spreadsheet shows the sources of funds with \$300,000. coming from the Mercer County American Rescue Act Funds, and \$10,500.00 would remain out of the authority funds. There is still a 5% contingency (unforeseen items) that's about \$14,000.00 and Dan believes we have enough funds for this project. The equipment needed for this project will be in around Jan/2023.

*A motion was made by Walt Darraugh and seconded by Robert Gregory to award the bids for Contract #1 & Contract #2 as specified above and listed in the Engineer's Report, contingent upon receipt of acceptable bonds and certificates of insurance. Motion carried. Matthew McConnell abstained.

There was discussion on how to obtain the money from the county. It was suggested to get a hold of John Logan to get the process moving.

OPERATOR'S REPORT

The plant flow in April/2022 was 90,000/gal/day.

Our NPDES Permit expires in August/2024.

No sludge was hauled.

There are still issues at Countryside from grease and may need to be dug up and cleaned out.

There was one grinder pump repair.
