Amend resolution 2023-117 regarding a Supplemental Engineering Agreement for the Ohl Street bridge project. Move the \$100,913.20 scope from final design services (Part II) to preliminary engineering (Part I) of the current Engineering Agreement No. 010P96. The scope continues preparations for demolition and includes potential cul-de-sacs and final right-of-way plan development.

Supplement \$140,265.68 of additional services to the current Engineering Agreement No. 010P96 for the Ohl Street bridge project. The scope provides environmental tasks to move through the NEPA process, an ATON plan, a public meeting, and structure removal sequence plans.

The total engineering agreement amount is now \$760,057.58. The Reimbursement Agreement No. R21010007 will also be adjusted to accommodate these changes. These project costs are 100% reimbursable (80% federal funds plus 20% state funds).

DISCUSSION: Bridge Engineer Brad Elder said that per the PennDOT published newsletter, Spring of 2025 is the LET date when it can be advertised to solicit bids.
